The Course

IRF India Chapter in association with Australian Road Research Board (ARRB) and Central Road Research Institute (CRRI) will organize the next set of two Certification Courses for "Road Safety Auditors" in May 2013. Road Safety Audit (RSA) at every stage of road development and operation is fundamental requirement for built-in safety for the infrastructure using road safety engineering principle. There will be two such training courses in two consecutive weeks during 20th-24th and 27th-31st May 2013. The training shall be imparted by both ARRB and IRF (India Chapter) experts having long experience on road safety engineering and audit. A Certificate shall be issued to each trained auditor. It is expected that these trained auditors only will be carrying out the RSA in the country in coming time.

Background

It may be mentioned that IRF in association with ARRB and CRRI had earlier organized eight such Certification Courses for Road Safety Auditors in 2010, 2011 & 2012 and has trained around 250 auditors till now. These courses have been highly appreciated both in India and abroad. This Road Safety Audit course was developed by IRF India Chapter in response to the observations by MoRT&H, NHAI and other Client organizations that there is scarcity of qualified road safety auditors in the country for carrying out audits of the road projects, particularly the BOT projects. IRF (India Chapter) is committed to the capacity development effort for Road Safety Audit (RSA) in India. Eligibility

Course Fee

The minimum educational qualifications for the trainees shall be a degree in Civil Engineering and/or post-graduate degree or diploma in Traffic Engineering/ Highway Engineering/ Transportation Planning/ Engineering. The attached application format shall be filled by the candidates enclosing a brief CV (two pages only), and shall be submitted with due authorization from the sponsor as application for attending the course. There are 30 seats only in each course, and the seats will be booked on first-come-first-serve basis and on satisfying qualification and experience criteria.

Who Should **Attend**

All the Government Departments and Road/Highway Authorities in Centre and States, Educational Institutions, Consultancy Organizations, and Concessionaires of road projects are requested to nominate their staff for these certification courses. The nominations should be accompanied by the Application Format duly filled and the fee (as cheque/DD).

The certification course fee is Rs. 50,000 per participant (+ service tax @ 12.36%). The Cheque/DD for the course fee may be made in favour of "International Road Federation, India Chapter" and payable at par at New Delhi. The fee shall cover the cost of guest house accommodation (in twin sharing basis) in CRRI Guest House, as a special facility only for the outstation candidates. It will also cover lunch and tea during all the days of the course, the course materials including those for design audit, and transport for field visits for actual sample practical audit works. Breakfast and dinner will be available at CRRI guest house on payment basis.
